DC/22/00724 Sampsons Hall, Hall Road, Kersey, Suffolk IP7 6EL

Proposal: Householder Application - Construction of swimming pool and erection of associated plant room.

Babergh granted permission 16 March 2022.

b) Planning applications to consider

DC/22/01013 Land Adjacent The Grain Store Cox Hill, Wickerstreet Green, Kersey, Suffolk IP7 6EY Proposal: Full Application - Erection of agricultural building for storage of plant and machinery and creation of new field access.

The applicant was not present.

Councillors discussed this application. It was noted that the Suffolk Wildlife Trust object due to the impact on wildlife, particularly Hazel dormice. It was resolved by a majority decision to object to this application. The main reasons for objecting were due to concerns about the destruction of hedgerow and dormouse habitat to create a new entrance to the field. Also, the possible contravention of wildlife regulations in relation to this site.

Proposal: Householder Application - Erection of a carthouse

Proposal: Full Planning Application - Conversion of alterations to existing outbuilding to form holiday let.
